

# **Diamond Fever, Inc.**

## ***Player Waiver, Release of Liability, Indemnification Agreement***

***This form must be completed and turned in prior to any practice or game activity.***

I, the undersigned player, or parent/guardian if under the age of majority, acknowledge, agree and understand that:

1. Voluntarily and of my own free will, the undersigned player elects to participate as a member of the baseball/softball team named below.
2. The undersigned player and/or parent/guardian (if applicable) understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to me or other players, including, but not limited to those hazards associated with weather conditions, playing conditions, equipment and other participants.
3. The undersigned player and/or parent/guardian (if applicable) understand that sliding into base is dangerous to me and to other players and may result in serious injury or death.
4. The undersigned player and/or parent/guardian (if applicable) understand that the very nature of the game of Baseball/softball is hazardous and risky, including, but not limited to, the acts of pitching, throwing, fielding and catching of the ball, the swinging of the bat, running, jumping, stretching, sliding, diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to all players, including the undersigned.

Further, the undersigned player and/or parent/guardian (if applicable), agree that in consideration for the right to play as a member of the team designated below and in consideration for permission to play on the fields arranged for by my team or Diamond Fever, Inc.:

1. The undersigned player and/or parent/guardian (if applicable) voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as team member during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the fields arranged for by my team or Diamond Fever, Inc. for practice or play.
2. The undersigned player and/or parent/guardian (if applicable) release, discharge and agree not to sue the team designated below, the sponsor designated below, Diamond Fever, Inc., or their owners, officers, agents, servants, associations, employees, or any person or entity connected with the team, league, field or Diamond Fever, Inc. for any claim, damages, costs or cause of action which the undersigned player, guardian/parent, or their heirs, executor, administrator, and assigns have or may have in the future as a result of injuries or damages, sustained or incurred by the undersigned player from whatever cause including but not limited to the negligence, breach of contract, or wrongful conduct of the parties hereby released.
